



## 2023 Oregon Veteran Directed Care Worker Rates & Employer Costs (Spouses, Parents, Children <18)

The following chart reflects the cost applied to an employer’s budget based on the hourly wage paid to a worker. In addition to the new standard rates, employers located within an urban growth boundary (UGB) and those located within a “nonurban” county, are subject to different minimum wage rates.
