

## UTAH DSPD HOW MUCH CAN I PAY?

EFFECTIVE JANUARY 1, 2025

The tables below represent the range of hourly cost to you to pay your employee. The "Cost to You" column includes the wage you are paying your employee + employer taxes + workers compensation insurance. Use the "Employee Wage" column to determine the hourly rate of pay for each employee.

The employee wages listed below are some examples. Employers are free to set an employee's wage provided it is not under minimum wage and not above the maximum rate for each service category.

Only maximum rates are allowed to be paid if you are participating in the Limited Supports Waiver.

**Note:** The Department of Labor requires any hours worked over 40 in a given work week (Sunday – Saturday) must be paid at time and a half unless a live-in exemption has been authorized.
